Omaha Habitat For Humanity is a non-profit organization that builds houses in partnership with families in need of affordable housing. We build in North East and South East Omaha where the need for such housing is greatest. Habitat For Humanity helps families overcome the barriers traditionally locking them out of the housing market – large down payments and interest-laden monthly payments.

Furthermore, the civil rights ordinance authorizes the Department to receive, initiate, investigate, settle, and dismiss charges of unlawful discrimination in employment, housing and public accommodations. The contract compliance ordinance covers contractors and vendors who do business with the city in the amount of \$5,000 and above. This ordinance requires that businesses that contract with the city must not discriminate in their employment practices. In addition, the ordinance requires that the Human Relations Department conduct employment/anti-discrimination training for all contractors and vendors who do business with the city. Furthermore, the Human Relations Department is responsible for certifying businesses for the city's minority/female/disadvantaged businesses contracting program.

Along with its enforcement activities, the Human Relations Department conducts seminars for the public, companies, and community groups regarding discrimination prevention and services provided by the Department. In addition, every year the Human Relations Department sponsors events honoring Dr. Martin Luther King, Jr., Black History Month, Hispanic Heritage Month, and the history and culture of Native American Indians.

The Nebraska Equal Opportunity Commission (NEOC) is a neutral administrative agency created by Nebraska statute in 1965. Our mission is to enforce the public policy of the state against unlawful discrimination. We receive, investigate and pass upon charges of unlawful discrimination occurring anywhere within the state in the areas of employment, housing, and public accommodations.

The NEOC is composed of seven members appointed for three-year terms by the Governor. As terms expire, the Governor may reappoint current members or new members. The NEOC may meet anywhere in the state to conduct business and four affirmative votes are necessary for a matter to be legal. The NEOC maintains its principal office in Lincoln with two other offices in Omaha and Scottsbluff respectively.

Laws enforced by the NEOC are Nebraska Fair Employment Practice Act (FEPA); Act Prohibiting Unjust Discrimination in Employment because of Age (Age Act); Equal Pay Act; Nebraska Fair Housing Act (NFHA); Act Providing Equal Enjoyment of Public Accommodation.
