Omaha Land Bank Ordinance Reflects REALTOR[®] Interests

Last year state senators worked with OABR Governmental Affairs Committee members and other Nebraska REALTORS® on legislation that is now initiating a more aggressive approach toward vacant and uncared for properties in the Omaha metro area.

Because of early REALTOR[®] involvement in the process, the Nebraska Municipal Land Bank bill (LB97), in its final form, reflected the concerns of the real estate profession. The bill was subsequently passed by the Nebraska Legislature and signed into law by Governor Heineman in June 2013.

Omaha REALTOR® and former OABR President, Joe Gehrki said, "The Nebraska REALTORS® Association was originally against the State legislation because it was viewed as another layer of government. The author of the bill, Senator Heath Mello, contacted the REALTORS® asking how we could support the bill. We helped the Senator completely re-vamp the bill to gain our support. The main change was to make this applicable to Douglas and Sarpy Counties only because these area's needed the majority of the assistance. With the REALTORS® support and assistance the bill passed."

Last month, as a result of LB97, the Omaha City Council approved the formation of the Omaha Municipal Land Bank. The new city ordinance will give a seven-member board the authority to purchase or accept donations of tax-delinquent, run-down and abandoned houses, vacant lots and other problem properties, then package them together and sell them for redevelopment. There are currently 770 houses scheduled for future demolition by the City and over 3,600 properties labeled unfit or unsafe within the Omaha city limits. The Land Bank hopes to reduce Omaha's urban blight, and put revitalized property back on the tax rolls.

In order to make this happen, the Land Bank will combine city funds with private donations, and then regenerate the funds upon the sale of the properties in order to repeat the process. Omaha Mayor Jean Stothert will appoint a seven-member board to operate the Land Bank. Omaha REALTORS[®] can expect to be represented with the appointment of at least one seat on the board.



Roof Inspections Important

During inspection walk-throughs one of the biggest questions buyers have is "what is the condition of the roof?" Home insurance companies are starting to focus more and more on that same question.

Ten years ago most insurance companies would insure composition and wood shake roofs without a lot of questions. If the roof looked in decent condition from the ground, chances are it would be insured.

In the last several years, insurance companies have tightened their qualifications for which roofs they will insure. This has become a problem for some home buyers who find out at the wrong time that the roof is not insurable.

On a recent prelisting inspection a wood shake roof needed repairs at isolated areas due to wear and wind damage. I recommended further evaluation and



repair as needed by a qualified roofer. In my mind this roof had a lot of life left to it, if it was repaired properly. The seller had a handyman repair the roof instead of a qualified roofer. The seller then sold the house to a friend who did not get their own home inspection. When the new buyer went to get insurance, the insurance company informed the buyer the roof was too worn and old and could not be insured.

The buyer then tried other insurance companies, but found that other companies where denying coverage based on information entered into a database from the first insurance company's evaluation.

Ever since this experience we have been making the following suggestions when we see a roof that has even minor hail damage or moderate aging and wear.

For possible hail or weather damage:

Have the seller contact their insurance company to send out an adjuster to see

if there is damage that would call for a claim.

For worn and older roofs:

Have the buyer's insurance agent view the roof to verify they would insure it before they purchase the home.

The insurance companies are in control here and they are the ones who have recently tightened the requirements for what roof is insurable. Home inspectors and roofers can make evaluations, but the insurance company is the

Several factors can influence concrete and cause it to crack. Cracks in basement floors are very common and, in most cases, should not be a significant concern. A basement floor is typically 3"- 4" thick concrete, and its purpose is to provide a smooth even surface (similar to a driveway or sidewalk). It is usually not a structural component of the home, and the cracks normally do not affect the foundation. It is a good idea to seal the cracks with a good quality concrete sealant, especially if you are planning on finishing the basement. You should be concerned and consult a qualified contractor if the following occur:

- The basement floor begins to settle or heave
- The floor becomes uneven at the cracks
- Moisture or moisture staining appears at the cracks.
- Foundation wall cracks occur that are in alignment with the floor cracks

These can indicate possible foundation problems, water seepage problems, soil erosion problems or sewer problems.




