# Never underestimate the power of teamwork!

"IT IS A FACT THAT IN THE RIGHT FORMATION, THE LIFTING POWER OF MANY WINGS CAN ACHIEVE TWICE THE DISTANCE OF ANY BIRD FLYING ALONE."

That quote is featured on the motivational picture that hangs above my desk. The picture shows a flock of migrating Sandhill Cranes in a "V" formation moving across the morning sky. It's more than just an incredible site of the cranes taking wing at sunrise, it symbolizes a phenomenon in nature where, in order to advance and reach their collective destination, each crane has a specific job to do to benefit the entire group. The lead crane at the point of the "V" struggles to break the wind to advance the entire flock. In doing so, this act of breaking the wind

creates a vacuum behind both of the leader's wings where the following cranes can fly and slide into this vacuum where there is always less wind resistance and easier flying. Aerodynamically, this vacuum literally pulls all the trailing cranes in the "V" formation along with minimal effort. Over long distances, when the leader gets tired, it simply drops back in formation and away from the lead position, allowing one of the trailing cranes to fly up and take the lead for the greater good of the flock. The new leader now breaks the wind for their journey.

This simple act of nature is akin to the real estate industry. Your REALTOR® Association, from our national and state associations to our committees, we can learn a few things from Mother Nature. First, together we can fly higher, faster, and longer when we pull together and fly in our own "V" formation. Second, every dedicated member can contribute to the entire group when given the opportunity to lead. #### 7 Things Not to Do When Applying for a Mortgage

Often times, a borrower doesn't realize what may or may not create a challenge when it comes to their home loan. Following are some things to be mindful of during the mortgage loan process:

- **1.** Don't buy or lease an automobile Lenders look closely at your debt-to-income ratio. A large payment, such as a car lease, or purchase can greatly impact those ratios and prevent you from qualifying for a home loan.
- 2. Don't increase balances owed on credit cards If the new purchases increase the amount of debt you are responsible for on a monthly basis, there is a possibility this may disqualify you from getting the loan.
- **3.** Don't move assets from one bank account to another These transfers show up as a new deposit and complicate the application process, as you must then disclose and document the source of funds for each new account. The lender can verify each account as it currently exists. You can consolidate your accounts later if you need to.
- **4.** Don't attempt to consolidate bills before speaking with your lender The lender can advise you if this needs to be done.
- **5.** If possible, don't change jobs A new job may involve a probation period which must be satisfied before income from the new job can be considered for qualifying purposes. A new job may pay commission, overtime, or bonus income versus a guaranteed salary. Income other than a guaranteed salary must have a minimum of one-two years history before you can use it for qualifying.
- **6.** Don't run your own credit report This will show up as an inquiry on your lender's credit report. Inquiries can lower your credit score. All inquiries must be explained in writing, i.e. do you have new or more debt.
- **7.** Don't pack or ship information needed for the loan application Important paperwork for your home loan, such as W-2 forms, bank statements, divorce decrees, and tax returns should not be packed with your other household items. Finding copies could take weeks and delay the closing date on your new home.

And remember, it's never a bad idea to start with a consultation to set the stage correctly right from the beginning!



### **Know the Code**

#### Code of Ethics: Article 1

When representing a buyer, seller, landlord, tenant, or other client as an agent, REALTORS® pledge themselves to protect and promote the interests of their client. This obligation to the client is primary, but it does not relieve REALTORS® of their obligation to treat all parties honestly. When serving a buyer, seller, landlord, tenant or other party in a non-agency capacity, REALTORS® remain obligated to treat all parties honestly. (Amended 1/01)

#### Standard of Practice 1-1

REALTORS®, when acting as principals in a real estate transaction, remain obligated by the duties imposed by the Code of Ethics. (Amended 1/93)

#### Standard of Practice 1-2

The duties imposed by the Code of Ethics encompass all real estate-related activities and transactions whether conducted in person, electronically, or through any other means.

The duties the Code of Ethics imposes are applicable whether REALTORS® are acting as agents or in legally recognized non-agency capacities except that any duty imposed exclusively on agents by law or regulation shall not be imposed by this Code of Ethics on REALTORS® acting in non-agency capacities.

As used in this Code of Ethics, "client" means the person(s) or entity(ies) with whom a REALTOR® or a REALTOR®'s firm has an agency or legally recognized non-agency relationship; "customer" means a party to a real estate transaction who receives information, services, or benefits but has no contractual relationship with the REALTOR® or the REALTOR®'s firm; "prospect" means a purchaser, seller, tenant, or landlord who is not subject to a representation relationship with the REALTOR® or REALTOR®'s firm; "agent" means a real estate licensee (including brokers and sales associates) acting in an agency relationship as defined by state law or regulation; and "broker" means a real estate licensee (including brokers and sales associates) acting as an agent or in a legally recognized non-agency capacity. (Adopted 1/95, Amended 1/07)

#### Standard of Practice 1-3

REALTORS®, in attempting to secure a listing, shall not deliberately mislead the owner as to market value.

#### • Standard of Practice 1-4

REALTORS®, when seeking to become a buyer/tenant representative, shall not mislead buyers or tenants as to savings or other benefits that might be realized through use of the REALTOR®'s services. (Amended 1/93)

#### • Standard of Practice 1-5

REALTORS® may represent the seller/landlord and buyer/



tenant in the same transaction only after full disclosure to and with informed consent of both parties. (Adopted 1/93)

#### Standard of Practice 1-6

REALTORS® shall submit offers and counter-offers objectively and as quickly as possible. (Adopted 1/93, Amended 1/95)

#### • Standard of Practice 1-7

When acting as listing brokers, REALTORS® shall continue to submit to the seller/landlord all offers and counter-offers until closing or execution of a lease unless the seller/landlord has waived this obligation in writing. REALTORS® shall not be obligated to continue to market the property after an offer has been accepted by the seller/landlord. REALTORS® shall recommend that sellers/landlords obtain the advice of legal counsel prior to acceptance of a subsequent offer except where the acceptance is contingent on the termination of the pre-existing purchase contract or lease. (Amended 1/93)

#### • Standard of Practice 1-8

REALTORS®, acting as agents or brokers of buyers/ tenants, shall submit to buyers/tenants all offers and counter-offers until acceptance but have no obligation to continue to show properties to their clients after an offer has been accepted unless otherwise agreed in writing. REALTORS®, acting as agents or brokers of buyers/ tenants, shall recommend that buyers/tenants obtain the advice of legal counsel if there is a question as to whether a pre-existing contract has been terminated. (Adopted 1/93, Amended 1/99)

#### Standard of Practice 1-9

The obligation of REALTORS® to preserve confidential information (as defined by state law) provided by their clients in the course of any agency relationship or non-agency relationship recognized by law continues after termination of agency relationships or any non-agency relationships recognized by law. REALTORS® shall not knowingly, during or following the termination of professional relationships with their clients:

- 1. reveal confidential information of clients; or
- 2. use confidential information of clients to the disadvantage of clients; or

use confidential information of clients for the REALTOR®'s advantage or the advantage of third parties unless:

- a) clients consent after full disclosure; or
- b) REALTORS® are required by court order; or
- c) it is the intention of a client to commit a crime and the information is necessary to prevent the crime; or
- d) it is necessary to defend a REALTOR® or the REALTOR®'s employees or associates against an accusation of wrongful conduct.



# **Mold In Attics**

#### **By Steve Vacha** Home Standards Inspection Services

I recently popped my head into an attic of a nice looking well maintained 25 year old house. I saw immediately that the house had a ventilation problem because about 70% of the sheathing was black.

What caused this? The vast majority of time it is from inadequate attic ventilation. Warm, moist air passes through the drywall, light fixtures, etc. and gets trapped in the frigid attic area. Other causes can be improperly vented bath vents, plumbing vents or furnace and hot water flues. As the warm, moist air comes in contact with the very cold un-

derside of the roof sheathing it condensates and frosts.

> As the attic warms up, the frost melts and the wood sheathing becomes damp. That is all a wander

ing mold spore needs to thrive. It has found a happy home and is about to start a colony, so to speak. Mold will start eating away at the surface it has landed on. As years go by, this mold can continue to grow with the cycle of condensation at the attic.

Normally this mold is not the 'black mold' (Stachybotrys Chartarum), rather it is a common mold to our area like Aspergillus. Thank goodness we have Aspergillis. It is the same mold that helps to break down leaves and other fibrous things. Without Aspergillus, we would be buried in leaves.

How to Address this Issue:

- Check to see if a humidistat in the house is set too high.
- Improve the ventilation in the attic. In the last 20 years or so we have greatly improved how we ventilate attics. An attic normally has soffit and roof vents



which need to be balanced and properly placed.

- · Make necessary repairs to damaged flues or vents that are venting improperly into the attic.
- Treat the mold/discoloration. There are mold remediation companies that will kill the mold using an approved fungicide and then they will normally seal the area with an approved sealer.

It is important to remember the air is the attic normally does not enter the living area of a home for us to breathe. But, it can compromise the structural integrity of the attic sheathing. Mold in the attic

should be addressed or it will only get worse.




