In Omaha RPAC Opens Doors; Calls-for-Action Make the Difference!



On Tuesday, July 12 the Omaha City Council rejected a proposed ordinance that would have placed restrictions and costly delays on the demolition of older structures on privately-owned property.

Andy Alloway, 2016 President of the Omaha Area Board of REALTORS® testified before the City Council in opposition to the measure. Alloway made it clear that the REALTOR® organization supports the development of healthy, attractive neighborhoods, and supports historic preservation, however, this proposal went too far, contained a number of flaws and inconsistencies, and also infringed on the rights of private property owners.

Sections of the proposal contained subjective interpretations and overly vague standards making it difficult for anyone to apply the provisions consistently or to provide advance guidance. OABR utilized the services of a highly-qualified, national land-use consultant made available and paid for by the National Association of REALTORS®.

The uncertainties pointed out had the potential of reducing the amount of private investment in older neighborhoods, something Omaha can ill-afford. OABR's Governmental Affairs Committee and Board of Directors both concurred that the overall proposal, although it may have sounded good initially, was not a good long-term policy for Omaha.

For someone investing in a rundown neighborhood with a dream of revitalization, the proposed ordinance would have added untimely and costly delays. More significantly, it would have added uncertainty to the point where an investor might wonder if they would be able to finish and recoup their investment, given the City's new expanded authority over

the use of the land.



Nebraska Real Estate Commission & Coming Soon Listings

When is advertising a listed property, not entered in MLS, in the seller's best interest?

The Nebraska Real Estate Commission interprets license law and regulations to allow "coming soon" advertising if the following criteria are met:

- The advertising broker has an active listing agreement in place (so it is not potentially false or misleading advertising.)
- The advertising is done in the name under which the broker does business and the broker's supervision.
- The advertising is done with the knowledge and written consent of the property owner or his or her authorized agent.
- The listing is in fact "coming soon" and not currently being shown or marketed to a limited group only.

While permissible, the use of "coming soon" advertising has potential to give rise to violations of license law. The proper use of "coming soon" advertising would be a situation where a listing agreement has been entered into but the property or owner is not yet ready for showings, perhaps due to needed clean up or repairs, or personal matters or events that keep the owner from wanting to show the property immediately.

The improper use would be using the "coming soon" advertising to limit the showing of the property to preferred buyers, or the exclusion of certain buyers, this could lead to various violations of the license act, which would include but not be limited to:

- A violation of Neb. Rev. Stat. §81-884.24(2)
 "intentionally using advertising which is misleading or
 inaccurate" if the property is represented as "coming
 soon" and is in fact being marketed to a limited pool of
 buyers.
- A violation of Neb. Rev. Stat. §76-2417(c) "promote the interests of the client with the utmost good faith" if the coming soon listing is used to secure a transaction which places the interest of the licensee over that of the client.
- A violation of §76-2417(c)(i) "seeking a price which is acceptable to the client" if the licensee only offers or exposes the property to a limited number of potential buyers through a coming soon listing.
- A violation of the Federal Fair Housing Act if the coming soon listing is used to limit or exclude certain people or classes of people from the marketing of the property based on race, color, national origin, religion, sex, familial status or handicap.

"Optional" Title Insurance By: Wendy Walker



One fallout of "Know Before You Owe" is that title insurance is now referred to as "optional" in the closing disclosure form. While the jury is out on the impact this has had on consumer understanding of title insurance and its importance, failure by consumers to understand the various types of title insurance could have dire consequences.

Although the lender requires that the owner obtain title insurance through a Loan Policy, that policy protects only the lender. The lender policy covers the amount of the loan, only, and terminates when the loan is paid in full. Unfortunately, many mistakenly believe the **owner** has coverage under a Loan Policy.

"Title insurance protects the single largest financial investment most people make. One out of every three residential real estate transactions has an issue with the title, which is usually resolved by title professionals before the buyer closes." ALTA Home Closing 101

WHAT IS TITLE INSURANCE?

Title is the legal right that a person has to the ownership and possession of land.

Matters affecting ownership and other real estate interests are entered in public records. Title agents search the public records prior to closing any transaction in order to identify any "defects" in title. Defects could include items such as mistakes in the records, liens or easements, future interests, etc.

By identifying these problems prior to closing, the title defects can be remedied. In addition to remedying the defects, the buyer is given insurance coverage for those and certain other defects occurring prior to the closing but discovered at a later date.

All policies are unique so be sure to consult with a title agent about the specific coverage in your situation!

Basic v. Expanded Homeowner Policy

It is imperative to educate consumers about the various title insurance options available to the **owner**. There are two types of policies available to owners: Basic Owner and Expanded Homeowner coverage. Under either policy, if title is challenged based on a covered circumstance, the title insurer either "corrects" the defect or covers the costs up to the policy limits in the case of a valid claim. Additionally, consumers should understand that title insurance premiums are a one-time charge, billed at the time the home is purchased, and often cost less than an annual auto insurance premium.

The Basic Owner Policy, in general, protects against public record defects, such as: someone claiming an ownership interest in your title, leases, contracts or options affecting your title, someone claiming to have rights affecting your title due to forgery or impersonation, someone having a right to limit your use of the land, unmarketability of your title, and a defective title.

The Expanded Homeowner Policy, in general, provides basic and additional coverage against losses incurred as a result of zoning violations, subdivision law violations, improvements that encroach into an easement, building permit violations, covenants, conditions and restrictions, lack of vehicular and pedestrian access, supplemental assessments arising as a result of construction or a transfer prior to the policy date, damage to your house caused from someone with easement rights, and coverage if someone refuses to buy your land because your neighbor's structures are on your land. The policy also automatically increases by 10% in value, up to 150%.

In communications with the Council, OABR pointed out that if government is allowed to tell the owner of a property they can no longer use their property as intended, when their intention meets all other building codes and local zoning laws, then the owner has lost their rights in that property and the taking for public use is without fair compensation and directly flies in the face of an individual's constitutional right to own real property.

OABR and others urged the council to make corrections to the ordinance before they voted, but in response to Councilman Chris Jerram's request for an immediate up-or-down vote, the council agreed with the opposition and the proposal was defeated 4-3, with council representatives, Garry Gernandt, Aimee Melton, Rich Pahls, and Franklin Thompson supporting OABR.

OABR was joined by the Greater Omaha Chamber of Commerce, the Mayor's office, the Community Land Bank Board, the Metro Omaha Property Owners Association, the Omaha Real Estate Investors Association, and a number of individual, private developers all in opposition to the proposed ordinance as it was written.


In 2013, the formation of the Community Land Bank was supported by OABR, who worked with the Nebraska REALTORS® Association and the Nebraska Legislature

on the enabling legislation to encourage and facilitate the redevelopment of problem-properties in many of Omaha's high-crime locations. The ordinance presented for a vote, would have served to work against those efforts.

It was evident to the REALTOR® leadership that RPAC investments helped open doors and led to direct conversations with elected officials who listened and reacted positively on short-notice, since the coalition was initially unaware of the inconspicuous, seemingly-benign proposal that was moving forward.

Just as important were the immediate member responses to a last-minute Call-For-Action targeting OABR members residing within the City. Overnight more than two dozen emails were sent to some council member's inboxes. In the end it made a big difference.

A/C Maintence and Care an Investment in Your Home

By Steve Vacha Home Standards Inspection Services

Central air conditioners have two separate components: the Condenser and the A Coil (evaporator.) The condenser unit is usually located outside the house on a platform and the evaporator coil is mounted above the furnace.

The air conditioning system is one of the most complicated and expensive pieces of equipment in our homes. It is very important to do periodic maintenance and servicing of this equipment to keep it running at its maximum efficiency.

Servicing the AC on a yearly basis is recommended. Service typically consists of:

Checking to make sure there is

proper refrigerant in the system and there are no leaks.

- Cleaning the fins at the exterior compressor unit. If the fins become blocked with grass, dust and debris it reduces the ability for the refrigerant to be cooled down by the fan at the condenser.
- Cleaning the A Coil (evaporator) above the furnace. When the process of evaporation occurs, the warm air from the house passes over the A Coil, condensation occurs, due to the cooling of the air. This condensation then drips to the condensate pan that is above the furnace. The water in the pan then drains out condensate drain line to the floor drain. If this condensate pan becomes blocked due to lack of service, water



will drip into the furnace below and can damage the furnace. A surprising amount of water drains from this condensate pan, and if not properly directed to a drain, this will create a moisture problem in the area.

Good servicing of your units will keep you cool and keep your equipment running

efficiently.

Know the Code

Code of Ethics: Articles 13 - 14

Article 13

REALTORS® shall not engage in activities that constitute the unauthorized practice of law and shall recommend that legal counsel be obtained when the interest of any party to the transaction requires it. [listen]

Article 14

If charged with unethical practice or asked to present evidence or to cooperate in any other way, in any professional standards proceeding or investigation, REALTORS® shall place all pertinent facts before the proper tribunals of the Member Board or affiliated institute, society, or council in which membership is held and shall take no action to disrupt or obstruct such processes. (Amended 1/99) [listen]

Standard of Practice 14-1

REALTORS® shall not be subject to disciplinary proceedings in more than one Board of REALTORS® or affiliated institute, society or council in which they hold membership with respect to alleged violations of the Code of Ethics relating to the same transaction or event. (Amended 1/95)



Standard of Practice 14-2

REALTORS® shall not make any unauthorized disclosure or dissemination of the allegations, findings, or decision developed in connection with an ethics hearing or appeal or in connection with an arbitration hearing or procedural review. (Amended 1/92)

Standard of Practice 14-3

REALTORS® shall not obstruct the Board's investigative or professional standards proceedings by instituting or threatening to institute actions for libel, slander or defamation against any party to a professional standards proceeding or their witnesses based on the filing of an arbitration request, an ethics complaint, or testimony given before any tribunal. (Adopted 11/87, Amended 1/99)

· Standard of Practice 14-4

REALTORS® shall not intentionally impede the Board's investigative or disciplinary proceedings by filing multiple ethics complaints based on the same event or transaction. (Adopted 11/88)


