Core Values don't add any value to a company if hidden in a drawer. They must be known and shared with others in the organization and with the outside world.

Some ways and ideas to implement our Core Values on an ongoing basis, fusing them into our culture"

- Website & Bylaws (Currently doing)
- **Decision-making** when determining to have, putting together, and/or participating in events.

• During Meetings:

- All Core Values on the cover sheet of the monthly agendas to reference when making decisions during the monthly meetings.
- Highlight one of the Core Values at the beginning of a meeting to reinforce and help others remember, and live the organization's values.

• Pull-Up Banners:

- One Pull-Up Banner with all the Core Values could be in the Omaha Realtors' lobby and can be used at events.
- Multiple Pull-Up Banners. One Core Value per banner and one pull-up banner with the Purpose Statement. These would be placed throughout the events to make more of an impact and make it easier for people to read them.
- T-shirts with one Core Value on it, and the Think Affiliate First logo. Each Core Value
 could have a different color to add curiosity and make more of an impact. These would
 be used at different events, and Affiliate members could wear their company-branded
 name badge if they want to let others know whom they work for.
