- 4. Pending arbitration requests or hearings.
- 5. Unpaid arbitration awards or unpaid financial obligations to any other board or multiple listing service.

If an Applicant or Member resigns from another board with an ethics complaint or arbitration request pending, the OABR requires as a condition of membership in OABR that the Applicant submit to the pending ethics or arbitration proceeding in accordance with the established procedures of the OABR and abide by the decision of the hearing panel.
