AGREEMENT TO ABIDE BY THE OABR APPLICATION APPROVAL PROCESS

The OABR considers, among other things, the following in determining an applicant's qualifications for the membership being applied for:

1. All final findings of Code of Ethics violations and violations of other membership duties in any other board within the past three years.
2. Pending ethics complaints or hearings.
3. Unsatisfied disciplinary proceeding pending.
4. Pending arbitration requests or hearings.
5. Unpaid arbitration awards or unpaid financial obligations to any other board or multiple listing service.

If an Applicant or Member resigns from another board with an ethics complaint or arbitration request pending, the OABR requires as a condition of membership in OABR that the Applicant submit to the pending ethics or arbitration proceeding in accordance with the established procedures of the OABR and abide by the decision of the hearing panel.

AGREEMENT TO PAY ESTABLISHED OABR DUES, FEES, AND ASSESSMENTS
