The following items should be pre-ordered to ensure availability:

1. Education Center: \$30 audio-visual fee includes two lavalier mics, one handheld mic, 6,000-lumen HDMI LED projector with screen.
2. Boardroom: \$15 audio-visual fee includes 82-inch LED display monitor with HDMI connection.
3. \$10 set up fee for Chromebook or Windows laptop with presentation software and Zoom conference capabilities (limitations apply).
4. \$15 coffee fee. Cold water, soda, and other beverages are available from vending machine.
5. White boards - Available at no cost. NOTE: For use with dry-erase markers only.

Summary of rental guidelines:

1. Renter will be present and remain on the premises during the entire use period
2. Renter assumes all financial responsibility for any damage to the building, property, or equipment
3. Renter assumes all financial responsibility for theft of property, equipment, or furnishings, including bathroom items, remote controls, or cables
4. Renter agrees to leave the premises in a clean and orderly condition with tables and chairs returned to original position. Failure to do so will result in a cleaning fee being assessed to the renter
5. Any costs associated with trash removal, or repairs will be assessed to the renter
6. Renter is responsible for turning lights off, securing doors, and returning keys as instructed
7. Renter agrees to indemnify OABR for liability arising from renter's use of the building. Renter is responsible for any necessary license
8. Smoking is not permitted on OABR property
9. OABR's maximum liability is limited and shall not exceed the amount of money paid by the renter
10. Catering of other food items and beverages is allowed, but only with permission
11. All rentals are subject to a formal rental agreement which must be agreed to before access is granted
